## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION transferring \$58,602.00 within the 2002 General Fund and authorizing the Director of Purchasing to execute a five-year lease with Tri-City Baptist Church of Independence, Missouri, under RFP No. 119-01, for office space for use by the Jackson County Board of Election Commissioners, at an annual cost of \$145,413.00, and a cost of \$121,178.00 for the remainder of calendar year 2002.

WHEREAS, the Purchasing Director has requested formal written proposals under RFP No. 119-01 for the furnishing of leased office space in the Independence Square area for use by the Jackson County Board of Election Commissioners; and,

WHEREAS, the only bid received was from Tri-City Baptist Church of Independence, for space located at 215 North Liberty in Independence, in the annual amount of \$145,413.00; and,

WHEREAS, the Purchasing Director recommends that the lease with Tri-City Baptist Church be approved as it has submitted the lowest and best proposal; and,

WHEREAS, in order to fund the lease payments for 2002, a transfer is necessary; and,

WHEREAS, the County Executive has recommended said transfer; therefore,
