AN ORDINANCE transferring \$260,173.00 within and appropriating \$21,814.00 from the unappropriated surplus of the 1998 Special Road and Bridge Fund, and authorizing Change Order No. 1 to the contract with Superior-Bowen Asphalt Company of Kansas City, MO, for the 1998 Road Surface Reconstruction and Rehabilitation Project, No.2370, increasing the contract amount by \$281,986.51.		
ORDINANCE #2867, October 27, 1998		
INTRODUCED BY John C. Graham, County Legislator WHEREAS, the County did, by Resolution 12194, dated April 27, 1998, enter into a contract with Superior-Bowen Asphalt Company of Kansas City, MO, in the amount of \$1,053,316.35, for the 1998 Road Surface Reconstruction and Rehabilitation Project, No.2370; and,		
WHEREAS, the proposed Change Order No. 1, a copy of which is attached hereto and incorporated herein by reference, is necessary to adjust various quantities due to the addition of seven roads, and said change order will result in an increase not to exceed \$281,986.51; therefore,
