IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION authorizing the County Executive to execute a First Addendum to the Agreement with Truman Medical Center, to provide additional grant match funding for its Teen MOMS program, for the purpose of expanding its services to Eastern Jackson County, in an amount not to exceed \$20,611.00.

RESOLUTION #13241, June 5, 2000

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, the voters of Jackson County, Missouri, approved imposition of a sales tax for seven years to provide funding for the fight against illegal drugs in our community; and,

WHEREAS, the proceeds and interest generated from this tax are deposited in a special Jackson County Anti-Drug Sales Tax Trust Fund that is segregated and not commingled with the general fund or any other special funds of the County; and,

WHEREAS, Resolution 12917, dated October 18, 1999, authorized the County Executive to execute a contract out of anti-drug sales tax funds with Truman Medical Center, to provide a grant match for its Teen MOMS program, at a cost to the County of \$49,973.00; and,

WHEREAS, the Prosecuting Attorney now recommends increasing this contract in an amount not to exceed \$20,611.00, for the purpose of extending the geographic area in which services are provided into Eastern Jackson County upon the terms and conditions of the First Addendum attached hereto; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be, and hereby is, authorized to execute the attached First Addendum to the Agreement with Truman Medical Center; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be, and hereby is, authorized to make all payments, including final payments on the Agreement and the First Addendum thereto.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
