IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a one-year term and supply contract for the furnishing of maintenance and parts for the electronic security system at the detention center for use by the Corrections Department to Southern Steel of San Antonio, TX, at an estimated cost to the County of \$76,575.00, as a sole source purchase.

RESOLUTION # 14821, December 8, 2003

INTRODUCED BY Scott Burnett, County Legislator

WHEREAS, Section 1040.1 of the Jackson County Code, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends a contract with Southern Steel of San Antonio, TX, in the estimated amount of \$76,575.00, for the furnishing of maintenance and parts for the electronic security system at the detention center for use by the Corrections Department to provide for departmental needs for the upcoming one-year period; and,

WHEREAS, the Purchasing Director further recommends that he not take competitive bids with regard to said contract for the reason that Southern Steel of San Antonio, TX, is the only known vendor capable of providing maintenance and parts its proprietary on-site security system at the

detention center; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County a contract with Southern Steel, of San Antonio, TX, and any and all documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments including final payment on the contract, to the extent sufficient appropriations to the using spending agency have heretofore been made in the current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
