WHEREAS, Section 1040.1 of the <u>Jackson County Code</u>, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends a contract with Southern Steel of San Antonio, TX, in the estimated amount of \$76,575.00, for the furnishing of maintenance and parts for the electronic security system at the detention center for use by the Corrections Department to provide for departmental needs for the upcoming one-year period; and,

WHEREAS, the Purchasing Director further recommends that he not take competitive bids with regard to said contract for the reason that Southern Steel of San Antonio, TX, is the only known vendor capable of providing maintenance and parts its proprietary on-site security system at the
