appropriations; and,

WHEREAS, pursuant to Section 1054.6 of the <u>Jackson County Code</u>, 1984, the Director of

Purchasing recommends the award of twelve (12) month term and supply contracts to

Robinson/Brancato of Grandview, MO and to Brinker Missouri, Inc. d/b/a On the Border Catering of

Lee's Summit, MO as the best bidders; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that awards be made to

Robinson/Brancato of Grandview, MO and to Brinker Missouri, Inc. d/b/a On the Border Catering of

Lee's Summit, MO, and that the Director of Purchasing be, and is hereby, authorized to execute for

the County any documents necessary for the accomplishment of the award; and,

all payments, to the extent that sufficient appropriations are available.
