WITHDRAWN 10/13/1998

AN ORDINANCE levy a special assessment of one-half of one percent of assessment valuation upon all lots, tracts or parcels of land, including improvements, in Sewer Districts Nos. 93, 95, and 103 for the maintenance, repair and administrative expenses of the sewers in Sewer Districts Nos. 93, 95, and 103.

ORDINANCE # 2855, September 29, 1998

INTRODUCED BY Victor E. Callahan, County Legislator

WHEREAS, Sewer Districts Nos. 93 (Fairview Heights), 95 (Salem East), and 103 (Trophy Estates), were created by ordinance of the County Legislature or order of the former County Court pursuant to sections 249.430-.660 RSMo); and,

WHEREAS, pursuant to section 249.640, RSMo, the Director of Public Works, acting as the Sewer Engineer of Sewer Districts Nos. 93, 95, and 103, has determined that sewer rehabilitation is needed in Sewer Districts Nos. 93, 95, and 103; and,

WHEREAS, section 249.640, RSMo, empowers the County Legislature and County Executive, upon the recommendation of the Director of Public Works, to levy a special assessment upon all lots, tracts or parcels of land, including improvements, in any sewer district established as provided in sections 249.430 to 249.660, RSMo, for the maintenance, repair and administrative expense of the sewers in such sewer district or districts, the assessment to be levied according to the lots, tracts or parcels of real estate including improvements, as shown upon the assessment books prepared by the assessor of the county, such assessment not to exceed one-half of one percent of such assessed valuation; therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

A special assessment of one-half of one percent of assessed valuation shall be levied upon all lots, tracts or parcels of land, including improvements, in Sewer Districts Nos. 93, 95, and 103, provided however that no special assessment shall be made against any land that has not had a plat finally approved.
