WHEREAS, by Resolution 16286, dated May 7, 2007, the Jackson County Legislature authorized an Agreement between Jackson County, MO, and Kansas City, MO, whereby the County agreed to manage Intersection Improvement Phase I Blue Ridge Boulevard and Wornall Road Project No. 3086; and,

WHEREAS, by Resolution 16462, dated November 26, 2007, the Legislature authorized a Professional Services Agreement with Wilbur Smith Associates for engineering services on the Blue Ridge Boulevard and Wornall Road Intersection Improvements Project No. 3086, at a cost not to exceed \$93,140.00; and,

WHEREAS, a First Addendum is necessary to cover additional construction services requested by Kansas City and not covered in the original Agreements "Scope of Services," at an increased cost not to exceed \$57,006.00; now therefore,
