### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** transferring \$107,580.00 within the 2014 Special Road and Bridge Fund for the furnishing of an upgraded dispatching software and hardware system for use by the Sheriff's Office.

**RESOLUTION NO. 18655**, November 3, 2014

**INTRODUCED BY** Crystal Williams, County Legislator

WHEREAS, the Sheriff's Office's dispatching software system is unreliable and obsolete and needs to be replaced to provide for wireless data communication from the on-board computers in the Sheriff's fleet; and,

WHEREAS, a new system is available from an existing term and supply contract with Alexander Open Systems, but a transfer is needed to cover the cost of this equipment; and,

WHEREAS, the County Executive recommends this transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be made within the 2014 Special Road and Bridge Fund:
