A RESOLUTION transferring \$107,580.00 within the 2014 Special Road and Bridge Fund for the furnishing of an upgraded dispatching software and hardware system for use by the Sheriff's Office.

RESOLUTION NO. 18655, November 3, 2014

INTRODUCED BY Crystal Williams, County Legislator

WHEREAS, the Sheriff's Office's dispatching software system is unreliable and obsolete and needs to be replaced to provide for wireless data communication from the on-board computers in the Sheriff's fleet; and,

WHEREAS, a new system is available from an existing term and supply contract with Alexander Open Systems, but a transfer is needed to cover the cost of this equipment; and,

WHEREAS, the County Executive recommends this transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be made within the 2014 Special Road and Bridge Fund:
