AN ORDINANCE appropriating \$18,574.00 from the undesignated fund balance of the 2016 Sheriff's Revolving Fund for the purchase of computer equipment for use by the Sheriff's Office.

WHEREAS, section 50.535 of the Missouri Revised Statutes provides that the fees collected to process concealed carry permit applications will be placed in a separate interest-bearing fund and may be used specifically for equipment, training, and other necessary expenditures within the Sheriff's Office; and,

WHEREAS, the Sheriff has recommended the purchase of computer equipment to upgrade its mobile ticketing operation using an existing term and supply contract; and,

WHEREAS, an appropriation is necessary in order to place the required funds in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
