WHEREAS, Section 1040.1 of the <u>Jackson County Code</u>, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends the award of a term and supply contract, for the furnishing of Teslin inserts for inmate ID wrist bands for use by the Department of Corrections to QueTel Corp. of Herndon, VA; and,

WHEREAS, the Purchasing Director further recommends that he not take competitive bids with regard to said contract for the reason that QueTel Corp. of Herndon, VA, is the only known supplier providing Teslin inserts for its proprietary inmate ID wrist bands; therefore,
