WHEREAS, the COMBAT Department has a need for television production, marketing, and air time for public service announcements regarding the COMBAT Drug-Crime Hotline for the period of July 20, 2009, through August 9, 2009; and,

WHEREAS, in consideration of the unique nature of the television industry and the specific markets served by and viewership ratings of the provider, the Director of COMBAT recommends award to KCCP Trust d/b/a Time Warner Cable of Milwaukee, WI, at a cost to the County not to exceed \$20,000.00; and,

WHEREAS, a transfer is necessary to fund this expense; and,

WHEREAS, the County Executive recommends said transfer; now therefore,
