## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** appropriating \$303,276.60 from the fund balance of the 2009 Anti-Drug Grant Fund in acceptance of the 2007 Byrne Justice Assistance Grant (JAG) from the U. S. Department of Justice and authorizing the County Executive to execute a Cooperative Agreement and an Amendment to the Cooperative Agreement pursuant to the terms of the grant award with the City of Kansas City.

**ORDINANCE #4178**, November 23, 2009

**INTRODUCED BY** Dan Tarwater, County Legislator

WHEREAS, the U. S. Department of Justice has awarded the City of Kansas City a grant in the total amount of \$919,020.00 to provide for anti-drug and other crime control measures for the period of October 1, 2007, to September 30, 2011; and,

WHEREAS, the grant allocates \$303,276.60 to the County for salaries and benefits for the employees of the Jackson County Drug Court Program and for re-entry services; and,

WHEREAS, this grant requires no local matching funds, but does require the execution of the attached Cooperative Agreement and Amendment to the Cooperative Agreement with the City of Kansas City; and,

WHEREAS, an appropriation is necessary in order to place the grant funds in the appropriate spending accounts; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the fund balance of the 2009 Anti-Drug Grant Fund be and hereby is made:
