IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a one year contract for the maintenance of the Records Department's FileNET software to FileNET Corporation of Costa Mesa, CA, at a cost to the County not to exceed \$7,096.89, as a sole source purchase.

RESOLUTION #13261, June 26, 2000

INTRODUCED BY Ronald E. Finley, County Legislator

WHEREAS, Section 1040.1 of the <u>Jackson County Code</u>, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends an agreement with FileNET Corporation of Costa Mesa, CA, for the maintenance of the Records Department's FileNET software; and,

WHEREAS, the Purchasing Director further recommends that he not take competitive bids with regard to said contract for the reason that the FileNET Corporation of Costa Mesa, CA, is the only known supplier legally authorized to maintain its own FileNET software; therefore, BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County a maintenance agreement with FileNET Corporation of Costa Mesa, CA, in an amount not to exceed \$7,096.89; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
