## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** transferring \$15,392.00 within the 2006 General Fund and \$33,377 within the 2006 Anti-Drug Sales Tax Fund, appropriating \$93,769.00 from the unappropriated surplus of the 2006 Grant Fund, and authorizing the County Executive to execute Amendment #3 and Amendment #4 to the Memorandum of Agreement with the Kansas City Metropolitan Crime Commission regarding the Project Safe Neighborhoods program.

**ORDINANCE # 3797,** August 14, 2006

WHEREAS, the Kansas City Metropolitan Crime Commission (KCMCC) has awarded a grant to the Prosecuting Attorney's Office in the amount of \$45,000.00, for its Project Safe Neighborhoods program, which the County will use to fund one full-time prosecutor to assist in the prosecution of federal and/or state criminal charges related to firearms crimes; and,

WHEREAS, this grant is subject to a local match in the amount of \$48,769.00; and.

WHEREAS, a transfer and appropriation are necessary to place the matching and grant funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer and appropriation; now therefore,
