### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** awarding a five (5) month term and supply contract on Electronic Solicitation No. BB200254 for the furnishing of mattresses, bedding, and linens for use by the Department of Corrections to Robinson Textiles of Gardena, CA (\$12,000.00), Tab Textile Co., Inc., of Opelika, AL (\$19,000.00), and Anchortex Corporation of West Berline, NJ (\$1,000.00), in the estimated aggregate amount of \$32,000.00.
