WHEREAS, the County has applied for funds for the reconstruction of the Longview Lake Trail, and the application was approved in the amount of \$250,000.00 for the rehabilitation; and,

WHEREAS, the attached Intergovernmental Cooperative Agreement is necessary for the County to accept these funds; and.

WHEREAS, the Missouri Department of Transportation specifically requested the adoption of an ordinance authorizing the supplemental agreement pursuant to the federal reimbursement
