WHEREAS, pursuant to section 9141.00, of the Jackson County Code, the Legislative Auditor has heretofore prepared a request for proposals and has mailed same to potential, interested parties; and,

WHEREAS, the selection committee provided by section 9142.00, of the Jackson County Code, consisting of the Finance and Audit Committee and the Manager of the Division of Finance, with the aid of Legislative Auditor, has reviewed the proposals and has recommended the retention of Mike Harmon and Kathy Allen-Gray to provide services as advisors to the Board of Equalization at an aggregate cost to the County not to exceed \$15,000.00; therefore,
