IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$33,718.00 from the fund balance of the 2010 General Fund for use by the Circuit Court to cover special prosecutor's fees.

ORDINANCE #4280, December 13, 2010

INTRODUCED BY James D. Tindall, County Legislator

WHEREAS, by order of the Circuit Court, special prosecutors are appointed to handle the prosecution of particular cases, most often when the Prosecuting Attorney's Office has a conflict of interest in the matter; and,

WHEREAS, special prosecutor Charles H. McKenzie has submitted an invoice in the amount of \$52,000.00 for special prosecutor fees which have been found to be reasonable and necessary by order of the Circuit Court; and,

WHEREAS, the budget line item for Special Prosecution has a current balance of \$18,282.00 and an appropriation is necessary to cover the costs in excess of that amount; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,
