WHEREAS, two (2) responses were received of which one (1), Loomis Fargo & Company of Riverside, MO, was determined to be "Non-Responsive" due to that response's exception to the terms and conditions of the proposed contract which would limit their liability in the event of loss or damage. recommended by the Director of Purchasing, and that the Purchasing Director be and hereby is

authorized to execute for the County any documents necessary for the accomplishment of the award;

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make

all payments to the extent that sufficient appropriations are available.
