Floor Amendment January 10, 2011

#### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** repealing schedule II to chapter 2, <u>Jackson</u> <u>County</u> <u>Code</u>, 1984, relating to the salaries of County employees not within the merit system.

**ORDINANCE #4287**, January 10, 2011

**INTRODUCED BY** Scott Burnett, County Legislator

WHEREAS, the County Counselor has requested the addition of an investigator/paralegal position to the schedule of salary ranges for the employees of his office; and,

WHEREAS, the addition of this position will allow the County Counselor the flexibility to reorganize the office in a manner that, in his opinion, best accommodates the skills of existing staff and will not result in the creation of a newly-budgeted position or a new hire; and,

WHEREAS, the range proposed for this position is the same as that of similar investigator positions in the office of Medical Examiner and Prosecuting Attorney; and,

WHEREAS, the County Counselor has also requested that the title and range for the executive secretary position in his office be modified to match those of similar positions in Schedules I and II of

WHEREAS, [this] <u>these</u> modification<u>s</u> [is] <u>are</u> in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, as follows:

Section A. <u>Enacting Clause</u>. Schedule II to chapter 2, <u>Jackson County Code</u>, 1984, is hereby repealed and one new schedule enacted in lieu thereof, to be known as schedule II, to read as follows:
