IN THE LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION congratulating Lulu B. Johnson-Fielder on the occasion of her 100th birthday celebration.

WHEREAS, Lulu was an active member and president of the P.T.A. at Bruce Elementary School and volunteered with the Red Cross; and,

WHEREAS, she also served as a member of the Mount Olive Social Club and is a member of St. Stephen's Baptist Church; and,

WHEREAS, Lulu is treasured by her family and friends, who know her as a woman of great wisdom and stature; and,

WHEREAS, on May 8, 1999, family will host a celebration at the Downtown Marriott Hotel to honor this woman who is truly loved; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature congratulates Lulu B. Johnson-Fielder upon the occasion of her 100th birthday, and joins with her family and friends in recognition of this momentous celebration.
