A RESOLUTION awarding a term and supply contract for the furnishing of haydite for use by the Public Works Department to Buildex Corporation of Ottawa, KS, to provide for departmental needs for the upcoming one-year period, as a sole source purchase.

RESOLUTION # 16142, February 5, 2007

WHEREAS, the County desires to purchase haydite, an aggregate used in road surfacing and repair, for use by the Public Works Department; and,

WHEREAS, section 1030.1, <u>Jackson County Code</u>, eliminates the requirement for competitive bidding when the items to be acquired can be obtained from only one source; and,

WHEREAS, the Director of Finance and Purchasing recommends the award of a one-year term and supply contract for the furnishing of haydite to Buildex Corporation of Ottawa, KS, as a sole source provider, because Buildex is the only known provider of this commodity in the region; and,

WHEREAS, section 1055.00, <u>Jackson County Code</u>, requires that for any such purchase in excess of \$25,000, the Director of Finance and Purchasing shall submit the purchase to the Legislature for approval; now therefore,
