A RESOLUTION awarding term and supply contracts for the furnishing of liquid asphalt, asphaltic concrete, and rubberized sealant for use by the Public Works Department to Vance Brothers, Inc., of Kansas City, MO, and Paving Maintenance Supply Inc., of Lee's Summit, MO, under the terms and conditions of Invitation to Bid No. 55-09.

WHEREAS, the Director of Finance and Purchasing has solicited bids on Invitation to Bid No. 55-09 for the furnishing of liquid asphalt, asphaltic concrete, and rubberized sealant for use by the Public Works Department; and,

WHEREAS, Invitation to Bid No. 55-09 was issued with three pricing options, three (3) months, six (6) months, or Missouri Asphalt Price Index; and,

WHEREAS, Vance Brothers Inc., selected the three month pricing option and Paving Maintenance Supply Inc., selected the six month pricing option; and,

WHEREAS, the Director of Finance and Purchasing recommends that the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,

WHEREAS, award as recommended would result in awards to the following:
