IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$37,426.00 from the unappropriated surplus of the 1999 Grant Fund to cover the Victim Services Volunteer Coordinator Grant for the Prosecuting Attorney's Office's Victim Services Program, received from the Missouri Department of Public Safety, and the transfer of matching funds.

ORDINANCE 2911, April 6, 1999

WHEREAS, the Missouri Department of Public Safety has awarded the Prosecuting Attorney's office a grant in the amount of \$37,426.00 as funding for its Victim Services Volunteer Coordinator Program; and,

WHEREAS, this program serves crime victims; and,

WHEREAS, said grant is subject to a \$7,795.00 local match for which a transfer and appropriation are necessary; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the unappropriated surplus of the 1999 Grant Fund:
