WHEREAS, by Resolution 17006, dated September 14, 2009, the legislature did award a contract for the furnishing of a software management system for use by the Jackson County Medical Examiner's Office to VertiQ Software LLC, of Morgan Hill, CA, under the terms and conditions of Request for Proposals No. 30-09, at a cost to the County not to exceed \$116,150.00; and,

WHEREAS, the Medical Examiner now recommends additional programming to the software management system at a cost to the County not to exceed \$10,000.00; and,

WHEREAS, the additional programming and increase in the contract is in the best interest of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the increase to the contract with VertiQ Software LLC, of Morgan Hill, CA, in the amount of \$10,000.00, for the furnishing of programming changes to the software management system for use by the Jackson County
