AN ORDINANCE appropriating \$18,194.00 from the fund balance of the 2008 Grant Fund in acceptance of a grant received from the Office of State Courts Administrator for the Family Court Division's Domestic Relations Supervised Therapeutic Visitation Program.

WHEREAS, the Office of State Courts Administrator has awarded the Family Court Division a grant in the amount of \$18,194.00 to be used for the Domestic Relations Supervised Therapeutic Visitation Program; and,

WHEREAS, an appropriation is necessary to place the grant funds in the appropriate spending account; now therefore,
