A RESOLUTION awarding a term and supply contract on Bid No. 76-95 for the furnishing of petroleum products for use by various departments to Heathwood Oil Co., Inc. of Kansas City, KS, Lowe Oil Co. of Clinton, MO, Hoston Oil Co., Inc., of Kansas City, MO, and Century Lubricants of Kansas City, KS, to provide for their needs for the upcoming one-year period, in the estimated aggregate amount of \$40,876.50. WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 76-95 for the furnishing of petroleum products for use by various departments; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends that the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,

WHEREAS, award as recommended would result in awards to the following vendors:

BE IT FURTHER RESOLVED that the Manager of the Division of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agencies have heretofore been made in the current Jackson County budget...Attorney
