Land Use Committee Amendment March 6, 2000

### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE amending the districts established by the Jackson County Zoning Order by changing from A (Agricultural) to LI (Light Industrial), a certain  $5 \pm$  acre tract, and to RR (Residential Ranchette) District, a certain  $5 \pm$  acre tract.

**ORDINANCE 2991**, February 7, 2000

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "LI" (Light Industrial) District and "RR" (Residential Ranchette) District, so that there will be transferred from District A to Districts LI and to RO a tract of land described as follows:

DESCRIPTION: A 10 ± acre tract of land generally located 1/4 of a mile south of U.S. Highway 50, east of Missouri 7 Highway and west of Lone Jack-Lee's Summit Road and more specifically described in attachment to RLA.
