## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** awarding a contract for the furnishing of onsite training on Delphi software applications for use by the MIS Department, to Borland Software Corporation of Scotts Valley, CA, at a cost to the County not to exceed \$10,000.00, as a sole source purchase.

WHEREAS, Section 1040.1 of the <u>Jackson County Code</u>, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends a contract with Borland Software Corporation of Scotts Valley, CA, for the furnishing of onsite training on Delphi software application for use by the MIS Department; and,

WHEREAS, the Purchasing Director further recommends that he not take competitive bids with regard to said contract for the reason that Borland Software Corporation of Scotts Valley, CA, is the only known supplier of onsite training for its proprietary Delphi software; therefore,
