IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION authorizing the Jackson County Executive to execute an Agreement with the City of Grandview, Missouri, relating to the County's providing the City's local match to a grant from the Missouri Department of Public Safety to fund the City's Community-Oriented Policing Program (COPS) and related programs at a cost not to exceed \$6,310.00.

WHEREAS, the City of Grandview, Missouri, has been advised that it has been awarded a Community-Oriented Policing Program (COPS) grant from the Missouri Department of Public Safety and has requested that the County now provide the local match in the amount of \$6,310.00; and,

WHEREAS, the attached Agreement provides a suitable mechanism by which funds for the grant match can be turned over to the City of Grandview; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and is hereby authorized to execute an Agreement in a form substantially similar to that attached, with the City of Grandview, Missouri; and,

BE IT FURTHER RESOLVED that the Manager of the Division of Finance be and is hereby authorized to make all payments including final payment of the Agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
