IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION transferring \$33,295.00 within the 2000 General Fund and awarding a term and supply contract for the purchase of gear motors for automatic doors for use by the Department of Corrections at the Detention Center to Independent Electric of Kansas City, KS, to provide for departmental needs for the upcoming one-year period, in the estimated amount of \$45,000.00.

RESOLUTION 13470, December 11, 2000

INTRODUCED BY Terry Young, County Legislator

WHEREAS, Section 1040.1 of the <u>Jackson County Code</u>, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends a contract with Independent Electric of Kansas City, KS, for the purchase of gear motors for the automatic doors at the Jackson County Detention Center; and,

WHEREAS, the Purchasing Director further recommends that he not take competitive bids with regard to said contract for the reason, that after a thorough search, it has been determined that Independent Electric of Kansas City, KS, is the only known local supplier of motors meeting this need; and,

WHEREAS, a transfer within the 2000 General Fund is necessary to cover the costs of purchases to be made under this contract during 2000; and,

WHEREAS, the County Executive has recommended said transfer; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be made:
