IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION authorizing the County Executive to execute a First Addendum to the Agreement with Boys and Girls Club of Greater Kansas City, to provide additional grant match funding for the salary of a position instrumental to its Delinquency and Youth Violence Prevention Program, in an amount not to exceed \$30,000.00.

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, the voters of Jackson County, Missouri, approved imposition of a sales tax for seven years to provide funding for the fight against illegal drugs in our community; and,

WHEREAS, the proceeds and interest generated from this tax are deposited in a special Jackson County Anti-Drug Sales Tax Trust Fund that is segregated and not commingled with the general fund or any other special funds of the County; and,

WHEREAS, Ordinance 2807, dated June 1, 1998, authorized the County Executive to execute a contract out of anti-drug sales tax funds with Boys and Girls Club of Greater Kansas City, to provide an additional grant match for the salary of a position instrumental to its Delinquency and Youth Violence Prevention Program, at a cost to the County of \$30,000.00; and,

WHEREAS, the Prosecuting Attorney now recommends increasing this contract in an amount not to exceed \$30,000.00, upon the terms and conditions of the First Addendum attached hereto; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be, and hereby is, authorized to execute the attached First Addendum to the Agreement with Boys and Girls Club of Greater Kansas City; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be, and hereby is, authorized to make all payments, including final payments on the Agreement and the First Addendum thereto.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
