WHEREAS, the County Executive executed an Agreement dated December 28, 2004 which provided for \$100,000 as a local match to a U.S. Department of Justice grant; and,

WHEREAS, Move Up has requested an additional sum of \$32,400 for funding a community outreach staff position for a period of twelve (12) months; and,
