WHEREAS, Swope Parkway Health Center's "Health Care For The Homeless" program is an aggressive, mobile outreach program staffed by physician assistants, substance abuse counselors, outreach workers, case managers, and intake specialists, offered to the County's drug-abusing homeless population; and,

WHEREAS, Swope Parkway Health Center's "Health Care For The Homeless" program has requested \$90,000.00 in anti-drug sales tax funds to secure the continuation of this federally-funded program; and,

WHEREAS, these funds will be used as a portion of the local match to a United States Department of Housing and Urban Development grant in the amount of \$6,227,291.00 for this program; and,

WHEREAS, the Prosecuting Attorney has reviewed this proposal and recommends the expenditure of these funds; therefore,
