## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** enacting section 2133., <u>Jackson County Code</u>, 1984, relating to the collection of license issuance fees.

**ORDINANCE #4036**, September 22, 2008

INTRODUCED BY Scott Burnett, County Legislator

WHEREAS, the Collections Department presently bills for a merchants license issuance fee of five (\$5.00) dollars; and,

WHEREAS, section 150.150, RSMo, authorizes the County to collect a merchants license issuance fee of up to twenty-five (\$25.00) dollars with annual adjustments for the consumer price index for a maximum license fee of one hundred (\$100.00) dollars which shall be set by the governing body of the County; and,

WHEREAS, under these circumstances, the Legislature believes it appropriate that an increase in the merchants license issuance fee should be adopted to set the issuance fee at the amount authorized by law; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, as follows:

Section 2133., <u>Jackson County Code</u> , 1984, is hereby enacted to read as follows:  2133. <u>Collection of Merchant's License Issuance Fee</u> .
