WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 4-01 for the furnishing of ready mix concrete for use by the Public Works and Parks and Recreation Departments to provide for departmental needs for upcoming one-year period; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends that the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,

WHEREAS, award as recommended would result in estimated awards to the following vendors:

<u>Bidder</u>	<u>Estimated Award</u>
APAC Missouri Materials L.L.C. Harrisonville, MO	\$15,000 (Ready Mix Concrete)
Fordyce Concrete Co., Inc. Overland Park, Kansas	\$25,000 (Flowable Fill)

therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made to Fordyce Concrete Co. of Overland Parks, KS, for the reason that it has submitted, in the determination of the Legislature, the lowest and best bid, and that the Purchasing Director be, and is

hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agencies have heretofore been made in the current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
