IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$21,502.00 from the undesignated fund balance of the 2014 Anti-Drug Sales Tax Fund in acceptance of auction proceeds from the sale of six surplus vehicles for use by the Jackson County Drug Task Force.

WHEREAS, the County has received a payment in the amount of \$21,502.00 from Affiliated Auctioneers for the sales proceeds from six surplus vehicles sold at auction; and,

WHEREAS, an appropriation is necessary to place the payment in the proper spending account so that the funds may be used to purchase new vehicles using an existing term and supply contract; now therefore,
