IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding twenty-four month term and supply contracts on Bid No. 45-03 for the furnishing of janitorial services for use county-wide to Modern Maintenance of Lenexa, KS (\$337,860.00), ABM Janitorial, of Kansas City, MO (\$103,287.52), and MMMM of Raytown, MO (\$8,618.76), to provide for county-wide needs, in the estimated annual aggregate amount of \$346,766.28.

WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 45-03 for the furnishing of janitorial services for use county-wide; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends the contract be divided and awarded to the vendors submitting the lowest bid for each building to be served; and,

WHEREAS, award as recommended would result in estimated awards to the following vendors:

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contracts, to the extent that sufficient appropriations to the using spending agencies have heretofore been made in the current Jackson County budget.
