WHEREAS, pursuant to Section 1040.04 of the <u>Jackson County Code</u>, 1984, the Director of Purchasing requests authorization for the purchase of mobile radios for use by the Sheriff's Department from Motorola Communications of Glen Rock, NJ, the terms and conditions set forth in the State of Missouri's Contract No. C203006001, an existing government contract in an amount not to exceed \$98,717.33; and,

WHEREAS, pursuant to Section 1064.00 <u>Jackson County Code</u>, 1984, requires approval by the Legislature when the purchase price under an existing government contract exceeds \$25,000.00; and,

WHEREAS, the Director of Purchasing has determined that due to higher volume discounts offered to larger entities, the award be made under the following contract:
