IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a term and supply contract on Electronic Solicitation No. BB20025 for the furnishing of chemicals and fertilizers for use by the Parks and Recreation Department to Pro Source of St. Joseph, MO (\$33,739.00), Outdoor Equipment of Grandview, MO (\$20,515.00), Midwest Turf Management of Raymore, MO (\$14,645.00), Lesco, Inc., of Strongville, OH (\$45,138.00), and Estes of Springdale, AR (\$35,970.00), to provide for departmental needs for the upcoming one year period in the estimated aggregate amount of \$150,007.00.

WHEREAS, the Purchasing Director has solicited formal written bids on Electronic Solicitation No. BB20025 for the furnishing of chemicals and fertilizers for use by the Parks and Recreation Department; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends that the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,

WHEREAS, award as recommended would result in the estimated amounts for the respective vendors as follows:
