### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** awarding a term and supply contract on Electronic Solicitation No. BB20025 for the furnishing of chemicals and fertilizers for use by the Parks and Recreation Department to Pro Source of St. Joseph, MO (\$33,739.00), Outdoor Equipment of Grandview, MO (\$20,515.00), Midwest Turf Management of Raymore, MO (\$14,645.00), Lesco, Inc., of Strongville, OH (\$45,138.00), and Estes of Springdale, AR (\$35,970.00), to provide for departmental needs for the upcoming one year period in the estimated aggregate amount of \$150,007.00.
