WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends the contract be divided and awarded to the two vendors submitting the lowest bids; and,
WHEREAS, award as recommended would result in estimated awards to the following vendors: VENDOR BID

Automated Business Systems \$ 5,631.10 Overland Park, KS
