A RESOLUTION authorizing the County Executive to execute an Agreement with the YMCA of Greater Kansas City for its Blue Hills Together Americorps program, to provide a local match to a state grant, in an amount not to exceed \$57,498.00.

WHEREAS, the YMCA of Greater Kansas City's "Blue Hills Together Americorps" program is a nationally recognized program whose efforts increase public safety; and,

WHEREAS, the YMCA of Greater Kansas City has received a state grant from the Missouri Community Service Commission in the amount of \$203,993.00 for this program; and,

WHEREAS, the YMCA of Greater Kansas City has requested anti-drug sales tax matching funds in the amount of \$57,498.00 to continue the program; and,

WHEREAS, the Prosecuting Attorney has reviewed this request and recommends matching funding in the amount of \$57,498.00 from his grant match account; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to execute the attached Agreement with the YMCA of Greater Kansas City; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is hereby authorized to make all payments, including final payment on the Agreement...Attorney
