IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE amending the districts established by the Jackson County Zoning Order by changing from A (Agricultural) to RE (Residential Estates), a certain 6 ± acre tract.

ORDINANCE # 3382, July 7, 2003

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section 1. The Zoning Order of Jackson County, Missouri, and the official maps which are a part

thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the

"RE" (Residential Estates) District so that there will be transferred from District A to District RE a tract

of land described as follows:

Description: A 6 \pm acre tract of land generally located 1/2 mile east of Hillside School road on the south side of Hudson Road and specifically described as:

A tract of land containing 6.525 acres in the W 1/2 of the NW 1/4 of Section 17, Township 48 North, Range 29 West, Jackson County, State of Missouri being more particularly described as follows: Beginning at a point on the North line of the NW 1/4 of Section 17, 1004.33 feet, S88 06'16"E from the NW Corner of the NW 1/4 of Section 17; thence continuing along the North line of the NW 1/4 of Section 17, S8806'16"E, 319.84 feet to a point on the East line of the W 1/2 of the NW 1/4 of Section 17; thence along the East line of the W 1/2 of the NW 1/4 of Section 17, S0204'17"W, 888.67 feet; thence along a line parallel with the North line of the NW 1/4 of Section 17, N8806'16"W, 319.84 feet; thence along a line parallel with the East line of the W 1/2 of the NW 1/4 of Section 17, N0204'17"E, 888.67 feet to the point of beginning. Subject to all public and private roads and easements of record if any.

Section 2. The Legislature, pursuant to the application of Brian Smith (RZ-2003-307), requesting the

amendment embodied in this ordinance and with notice that the Jackson County Plan Commission

unanimously recommended this application in a public hearing on June 19, 2003, does adopt this

ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative

power pertaining to planning and zoning.

Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.
