A RESOLUTION authorizing Change Order No. 3 to the contract with Radmacher Brothers Excavation Co., Inc., for the Longview Road at Blue Ridge Project, No. 2075-3, increasing the contract amount by \$14,228.68.

INTRODUCED BY Lisa White Hardwick, County Legislator

WHEREAS, the County did, by Resolution 11581, dated January 29, 1997, enter into a contract with Radmacher Bros. Excavating Co., Inc., in the amount of \$2,446,573.75, for the Longview Road at Blue Ridge Project, No. 2075-3; and,

WHEREAS, subsequent change orders have adjusted the contract amount to the current authorization of \$2,626,466.80; and,

WHEREAS, the proposed Change Order No. 3, a copy of which is attached hereto and incorporated herein by reference, is necessary for the reason that during the course of construction various bid items had to be adjusted and new items added to meet existing field conditions, and said change order will result in an increase not to exceed \$14,228.68; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that Change Order No. 3 to the aforesaid contract is approved and the County Executive is authorized to execute the change order on behalf of the County; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments, except final payment, on the contract...Attorney
