AN ORDINANCE transferring \$8,553.00 within the 2004 General Fund and reappropriating \$42,763.00 from the unappropriated surplus of the 2004 Grant Fund to cover the Victim Services Advocates Grant received from the Missouri Department of Public Safety and the transfer of matching funds.

ORDINANCE # 3460, January 12, 2004

WHEREAS, the Missouri Department of Public Safety has awarded a Victim Services Advocates Grant in the amount of \$34,210.00 to the Prosecuting Attorney's Office to cover the salary and benefits for a victim advocate for its Victim Services Program; and,

WHEREAS, this grant is subject to a \$8,553.00 local match; and,

WHEREAS, a reappropriation and transfer are necessary to place the grant and matching funds in the appropriate spending accounts; and,

WHEREAS, the County Executive recommends said reappropriation and transfer; now therefore,
