WHEREAS, pursuant to Section 1040.04 of the <u>Jackson County Code</u>, 1984, the Director of Finance and Purchasing recommends the award of a twelve (12) month term and supply contract for the furnishing of these products for use by these departments to Kansas City Winwater Works Co. of Kansas City (Clay County), MO, under the terms and conditions set forth in an existing government contract; and,

WHEREAS, the Director of Finance and Purchasing has determined that, due to higher volume discounts offered to larger entities, award under the existing government contract is appropriate; and,

WHEREAS, pursuant to Section 1064. of the <u>Jackson County Code</u>, 1984, the Director of Finance and Purchasing requests approval by the Legislature of this purchase, which exceeds \$25,000.00;
