WHEREAS, pursuant to negotiations, Gary R. Walkup, Trustee to the Walter R. Walkup Trust, owner of property located at 13103 Wornall Road, Kansas City, MO, have agreed to convey the necessary right of way and easements to Jackson County, MO, for an amount not to exceed \$9,989.06; and,

WHEREAS, the Director of Public Works recommends payment to the property owner in a one-time lump sum; now therefore,
